- Measure 26-238 For and Against presentation: Colleen Carrol, Eviction Representation for All, and Nathan Clark, Building our Future Together each gave 10-15 min presentation. Q & A discussion followed.
- 2. Peaceful Villa Open House and Survey; Letter & Donation requests: Heather presented on Peaceful Villa Open House and regarding draft letter to Anna Shook, attached, requesting 2-week extension to comment period on Environmental Assessment, a hearing on EA, and increased accessibility for public review of EA. Allen motion, Claire second to send letter. All voted in favor except Simon abstained.

Heather urged that comments made on comment sheets at 3/11 Peaceful Villa Open House be sent to Home Forward. Brian motion, Allen second to send comments to Home Forward. All voted in favor except Simon abstained.

Heather summarized costs and donation request to reimburse Claude for his out-of-pocket costs for pizza and color copies (\$473.76), plus \$200 donation to Richmond Community

Church for use of their facilities. Amount requested \$ 673.76. **Motion by Brian, Debby second to reimburse amount requested**. Discussion: Allen added that 2,240 copies made on RNA copy card = \$224, so total amount of requested RNA \$ contribution would be \$897.76. Allen asked Claude how much is he requesting from RNA. He said he would be ok if RNA reimbursed either cost -- pizza or color copies – and up to RNA what to reimburse. **Brian withdrew earlier motion and moved to reimburse Claude for pizza \$298 and \$200 donation to church = \$498 Allen second. Heather, Allen, Brian, Debby voted FOR, Claire voted AGAINST, and Simon abstained.**
